

# **Official Rules for the 2026 Car Raffle of the 2026 Ford Bronco Sport Big Bend**

## **Sponsored by the Center for Enriched Living**

The Center for Enriched Living is a 501(c)(3) charitable organization located in Riverwoods, IL. The Center for Enriched Living (CEL) enriches the lives of individuals with developmental disabilities by maximizing their opportunities for personal success, fun and friendship, employment, and community involvement.

### TICKET PRICE

The purchase price of a single raffle ticket is \$100 each or \$275 for 3 tickets. Checks or money orders should be made out to the Center for Enriched Living. A "purchase" shall not occur and be binding on the Center for Enriched Living until funds received have cleared the bank. Accepted credit cards include Discover, Visa, MasterCard and American Express. Tickets may be purchased online at [www.ExperienceCEL.org](http://www.ExperienceCEL.org), by phone: 847.948.7001, by mail, or in person at the Center for Enriched Living, 280 Saunders Rd., Riverwoods, IL 60015. Ticket purchases are not tax deductible or refundable.

Each raffle ticket purchased shall constitute an "entry" into the raffle, and the person to whom the raffle ticket is registered shall be the "Entrant." Although more than one name may be provided on the ticket registration form, the ticket shall be registered to the first name listed, who shall constitute the sole Entrant for that ticket.

### QUANTITY OF TICKETS

The maximum number of tickets offered for sale is 1,299. Requests for ticket purchases (and therefore payments received) after all tickets are sold or following the drawing, will be returned to the buyer(s).

### ELIGIBILITY

Purchasers of raffle tickets must be legal residents of the United States and 18 years of age or older on, or before, Friday, February 13, 2026, for the Early Bird Raffle Drawing or on, or before, Monday, June 29, 2026, for the Grand Prize Car Raffle Drawing. If an Entrant's check or credit card is dishonored prior to the drawing, the entry ticket will be declared invalid, until a replacement is received. All check or credit card charges found declined after the drawing must be honored. A \$30 charge will be assessed for non-sufficient funds or stop payment checks. Void where prohibited by law.

### DRAWING

Completed entry tickets must be in the possession of CEL (280 Saunders Road, Riverwoods, IL 60015) by 5:00 PM CT on June 29, 2026, unless otherwise personally delivered to an authorized representative of CEL before the time of the drawing. The raffle will take place on Tuesday, June 30, 2026, with a random drawing at the office of Center for Enriched Living. The winner will be notified within 7 business days. It is the responsibility of the purchaser to provide a valid, deliverable mailing address, phone and/or email address for notification.

### PRIZES

The winning Entrant shall be the "winner" of the prize. Payment to or delivery of any prize will be made to the Entrant. It is the sole responsibility of the Entrant to allocate a winning prize to other participants in case of a multiple entry registration, and the winning Entrant shall hold harmless the Center for Enriched Living in case of conflicting claims or disputes among multiple claimants.

Within 7 days from notification, the prize winner must inform the Center for Enriched Living which prize they have selected. The winner must supply their social security number before the prize is tendered. The ticket holder is responsible for all taxes and fees, including, but not limited to federal, state and local income, sales and/or excise taxes, fees, assessments and like charges associated with the prize, including license, title and registration fees. Winner must complete a W-9 form before receiving prize. If the winner chooses the cash prize, the winner must process the prize payment within ninety (90) days of receiving notice they have won. CEL is not responsible for lost, delayed, misdirected, or returned prize notifications and payments. The Center for Enriched Living may substitute a prize of equal or greater value if an advertised prize becomes unavailable for any reason. If the 2026 Ford Bronco Sport Big Bend is not available (due to supply chain issues) when raffle winner is chosen on June 30, 2026, then CEL reserves the right to award the cash prize.

If required by law, CEL will withhold federal and/or state taxes from the prize value prior to prize distribution, and the winner may be required to remit additional funds to satisfy withholding requirements. At the time of this printing, federal law requires that a tax withholding on certain prize values must be collected from winners upon award and distribution.

Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time the prize is claimed will be followed. Winners of prizes over six hundred dollars (\$600) will receive a W-2G from CEL. Taxes will be withheld in accordance with IRS and State of Illinois guidelines. For tax reporting purposes, the fair market value of the prize, as determined by CEL, will be reported to the IRS.

**In the event a winner: (a) does not notify CEL within seven (7) days of the drawing; (b) is ruled ineligible for any reason; (c) refuses the prize; or (d) does not return requested documents, the prize will be forfeited and will be retained by CEL for charitable use.**

The winner will have a choice of a 2026 Ford Bronco Sport Big Bend or \$30,000 in cash. If the winner chooses the vehicle, the winner will receive the advertised 2026 Ford Bronco Sport Big Bend from Gillespie Ford. The winner may have the option to choose a different 2026 Ford Bronco Sport Big Bend vehicle, at the discretion of Gillespie Ford and their available inventory. If the winner enters into an agreement with Gillespie Ford to select a different vehicle than the 2026 Ford Bronco Sport Big Bend advertised in the raffle promotion, the winner will be responsible for paying any costs over and above \$30,000. In addition, if the winner chooses to take the vehicle as their prize, they are responsible for picking up the vehicle at Gillespie Ford, 18834 W. Grand Ave., Gurnee, IL 60031.

Entries received prior to February 13, 2026, will be eligible for a \$1,000 cash drawing. The ticket drawn for this prize will be re-entered in the drawing for the grand prize. Prizes are non-transferable. The Early Bird prize winner is responsible for all applicable taxes, and a W-9 may be required before receiving prize.

If fewer than 500 tickets are sold by the drawing on June 30, 2026, the Center for Enriched Living reserves the right to pay one-half of the gross collected ticket money in lieu of the car or cash prize.

#### WAIVER/LIMITATIONS OF LIABILITY

Entrants release the Center for Enriched Living, and its respective board, committee members, officers, volunteers, employees, and representative agents from any and all liability with respect to participation in the promotion and possession of the prize. Any liability of the Center for Enriched Living shall be limited to the ticket price paid. In the case of a dispute, CEL's decision shall be final.

Entrant agrees to allow the Center for Enriched Living to use their name and image without any compensation for any promotional activity related to this or any future raffle. Any and all addresses and contact information of the purchaser will not be released to the public.

By purchasing a raffle ticket, you agree to be bound by these rules and the decisions of CEL which shall be binding and final as to all matters related to the raffle.

The raffle and these official rules shall be subject to and governed by the laws of the State of Illinois. If a court of competent jurisdiction finds that any provision of these official rules, or their application to a particular persons or circumstances, is invalid or unenforceable to any extent, then the remainder of these office rules shall remain enforceable to the fullest extent permitted by law.
